#### Step 3. Identifying adaptation options (1)

#### Goal

 Creation of portfolio of adaptation options that could address identified climate impacts







#### Step 3. Identifying adaptation options (2)

- Identify adaptation options
  - Addressing your key climate threats identified in the climate risk assessment (Step 2)
  - In line with your adaptation objectives (Step 2)
  - Reduce exposure of vulnerable people, sectors or systems to climate-related hazards
  - Reduce vulnerability of people, sectors or systems exposed to climate-related hazards
  - Exploit new opportunities
  - Have extra social, economic, environmental benefits
  - Aim for a diverse set of adaptation options covering broad range of issues







#### Step 3. Identifying adaptation options (3)

Use relevant resources for sourcing adaptation options

### Step 4. Assessing and selecting adaptation options

#### **(1)**

#### Goal

- Creation of assessment factsheets of identified adaptation options to inform decision-making
- Decision-making to involve stakeholders and citizens and aspire for coordination across political, legal, institutional actors to increase synergies.
- Selection of adaptation measures to form part of the plan







### Step 4. Assessing and selecting adaptation options

- Agree on a set of assessment criteria together with stakeholders and citizens
- Assessment criteria to consider:
  - Effectiveness in reducing climate vulnerabilities and risks or enhancing resilience
  - Efficiency in addressing all likely futures
  - Co-benefits for regional or local development
  - Co-benefits for climate mitigation
  - Contributions to sustainability and social justice
  - Political and cultural acceptability
  - Timing/urgency for action
  - Costs










### Step 4. Assessing and selecting adaptation options

- Choose your approach in assessing costs and benefits of adaptation options
  - Cost-effectiveness
  - Cost-Benefit Analysis
  - Multi-Criteria Analysis
- Creation of factsheets with information and assessments
- Selection of adaptation options
