Role

- Determine the technical and general content of the apps
- Exchange information of complicated subjects linked to the bathing and the communication with the public

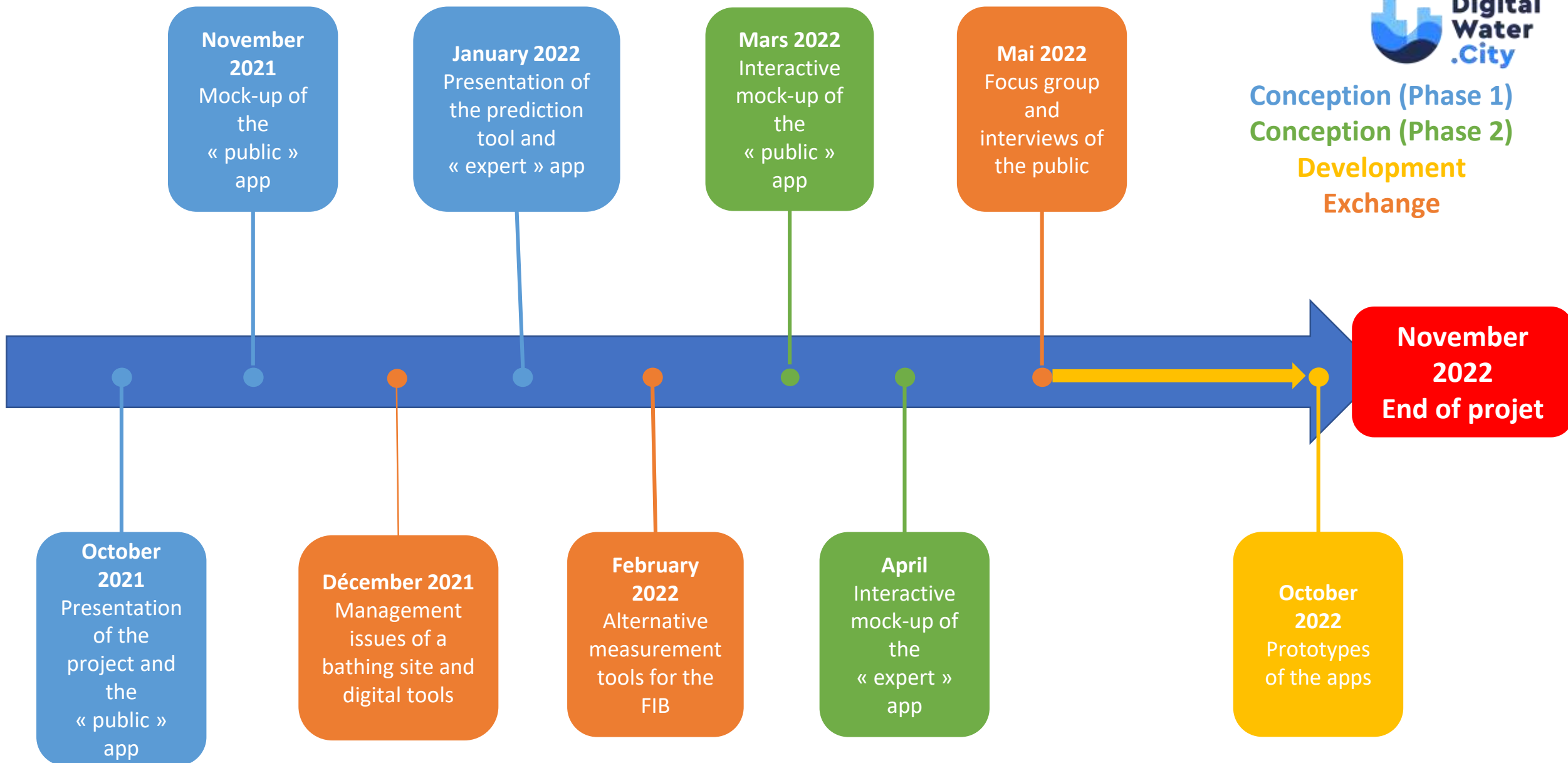
Access

- You can join the COP at any time
- A formal demand must be made to the responsible indicating the status of the member (active or passive)
- External entities can participate to meeting but not take part of the decision process

- Majority of the 2/3 des presents and represented people
- One voice per institution
